2016 Erie County Fair Junior Miss Pageant Rules

- Female contestants must be 9 - 12 years of age as of January 1st of this year
- Contestant must be an Erie County member of 4H or Girl Scouts and exhibiting at the fair
- Only 25 applications will be accepted for the pageant.
- Junior Miss pageant will be **Thursday, August 11, 2016** at 7 p.m.
- There will be a **mandatory** meeting **Sunday, August 7th** at 6 p.m. in the multi-purpose building at the fairgrounds. A parent must accompany their child to this meeting. We will discuss interviews, rehearsal, and the pageant at this meeting. Information will also be given on what to expect for the next year if chosen to be a member of the 2016 Erie County Fair Royalty.
- **Interviews** will be held **Thursday, August 11th** in the Senior Fairboard Office at the fairgrounds. Each contestant will participate in a 10 minute interview with the judges. Contestants are asked to arrive 15 minutes prior to their interview time. Contestants who may be showing during this interview time will be given first opportunity to sign up for interviews. (*Sign up for interviews will take place at the mandatory meeting.*)
- The girls will need to be ready no later than 6:00 p.m. the night of the pageant. They will need to have knee length shorts or capris (red or dark blue). They will then change into their "dressy dresses" for the remainder of the pageant. Dresses should be age appropriate. Please bring pageant dress to the mandatory meeting to get approved.
- The girls will be escorted on stage by an adult male (*father, grandfather, brother, friend, role model*) during the second half of the pageant. I will need the name of their escort the night of the mandatory meeting.

- The judges will make their final decision of who will be our 2016 Erie County Fair Junior Miss at the pageant. They will also decide who will be members of the 2016 Junior Miss Court (1st runner up, 2nd runner up, and Miss Congeniality).
- This is a year long commitment with many parades, festivals, fairs and lots of community service.
- The expectation for the 2016 Erie County Fair Royalty is to represent the Erie County Fair to the best of their ability and to have FUN!!!
