GOLF CART, FOUR WHEELERS, UTV POLICY

The Erie County Agricultural Society has approved a policy for the use of the above vehicles during the annual Erie County Fair.

- 1.) A fee of \$75.00 per vehicle will be charged and will be paid in the fair board office when you bring it to the fairground's property.
- 2.) You are required to bring a copy of your liability policy which specifically lists the vehicle as being insured when it is removed from your residential property. We also will keep on file a copy of your photo id.
- 3.) You will be assigned a numbered sticker which will be affixed to the vehicle at all times during the fair for identification purposes.
- 4.) **Anyone operating the vehicle on fairgrounds property must be eighteen (18) years of age and have a valid operator's license. Any violators will be asked to remove their vehicle immediately and will not be permitted to bring it back in the future.**
- 5.) **Use of golf carts, gators, four wheelers, UTV vehicles must have a permit obtained from the Fair Board Office.**
 - i. **Must be 18 or older and not driving recklessly at any time. First offense will be immediate removal of your golf cart, gator, four-wheeler or UTV and forfeit of your 2025 camping spot.**
 - ii. **Permits must be purchased by the end of day, Sunday, August 4th. If the UTV is caught on the grounds without the permit the cost will be \$150.00. If you choose to not pay that you will have to immediately remove your UTV for the remainder of the fair.**
- 6.) All passengers must be seated and no one will be allowed to stand anywhere on the vehicle while in motion.
- 7.) Any reckless operation of your vehicle will result in the immediate removal from the fairgrounds.
- 7.) No vehicles will be allowed on the **WEST** side of the animal barns or between the Horse barn/arena area and Hog Barn unless on official business of the Erie County Agricultural Society. ALL vehicles must stay behind all barns.
- 8.) Mini bikes or other small engine driven vehicles are not allowed on the property during the fair and are not included in this policy.
- 9.) If these rules are not being adhered to, at any time the Erie County Agricultural Society reserves the right to have the vehicle removed.
